RULES AND REGULATIONS

A. General

- The KL Bar Run 2021 ("KLBR") is organised by the KLBC Sports Committee ("KLBAR") in accordance with these Rules and Regulations ("R & Rs") and all the terms and conditions stated hereunder in this webpage are applicable to all Participants.
- 2. By signing up/registering for the KLBR and submitting information to KLBAR through this website, whether for the purpose of registering or otherwise, you signify that you have read, understood and agree to be bound by the R & Rs and the Privacy Policy as published in Kuala Lumpur Bar website at www.klbar.org.my in respect of KLBAR's collection, use, disclosure, and any other form of processing of your personal data.
- 3. Completion of the online registration form herein confirms the Participant's agreement to abide and be bound by these R & Rs.
- 4. Registration for the race is only confirmed upon payment and issuance of a receipt.
- 5. The Participant agrees to: (i) provide true, accurate, current and complete information about the Participant as per the registration form ("Personal Information"); and (ii) maintain and promptly update the Personal Information to keep it true, accurate, current and complete. KLBAR may contact the Participant from time to time by way of e-mail, telephone call, or facsimile. Any notice sent to the e-mail address registered with KLBAR shall be deemed as received by the Participant.
- 6. If the Participant provides any information that is untrue, inaccurate, not current and/or incomplete, and/or if KLBAR has grounds to suspect that such information is untrue, inaccurate, not current and/or incomplete, KLBAR may suspend or terminate the Participant's registration. KLBAR is also entitled to disqualify the team/participant in the event of the discovery of any such untrue, inaccurate, not current or incomplete information after the race is completed and/or at any time of such discovery.
- 7. KLBAR reserves the right to modify or substitute any of these R & Rs from time to time as they deem fit. If there is ambiguity in any of these provisions, KLBAR shall be the authority to interpret and in so doing, KLBAR will endeavour to take into account the interests of all the affected Participants. Any amendments to these R & Rs will be updated on the Kuala Lumpur Bar Website at www.klbar.org.my ("Official Website") or via e-mail to you.
- 8. KLBAR reserves the right to cancel the KLBR at any time without prior notice to the Participant, in which case they will make reasonable effort to inform the Participant prior to the date of the event. If the KLBR is cancelled, there shall be no refund of fees paid. KLBAR, Event Sponsors or Co-Sponsors shall not be liable for any loss or inconvenience caused.
- 9. KLBAR reserves the right to use any photographs, motion pictures, recordings, or any other media records (including those displaying the Participant) of the KLBR, for any legitimate purpose, including commercial advertising.
- 10. KLBAR reserves the right to limit and/or refuse race entries without assigning any reason.
- 11. KLBAR will not entertain nor be in any way responsible for any dispute arising from incomplete entry details.

B. <u>Safety</u>

- 1. Participant takes part in KLBR at his or her own risk and shall be responsible for his or her own safety. KLBAR, Event Sponsors or Co-Sponsors shall not be responsible or held liable for any injury or death howsoever arising from training for or during participation in KLBR. The Participant is strongly encouraged to consult his or her medical practitioner in respect of his or her health prior to registration and before the actual race day.
- 2. All Participants shall comply with the Prevention and Control of Infectious Diseases Act 1988 (Act 342) and all regulations made pursuant thereto including but not limited to the Prevention and Control of Infectious Diseases (Measures Within Infected Local Areas) (Movement Control) Regulations 2021 [P.U.(A) 8]. All running activities shall strictly in compliance with any standard operating procedure, guidelines, rules, and regulations as imposed by the relevant authorities from time to time. Unless otherwise allowed by the relevant authorities, no participant shall run in group or in any place which is closed.
- 3. KLBAR reserves the absolute right to postpone or cancel the KLBR as KLBAR deems fit in the interests and safety of the participants. There will be NO refund in the event of such postponement or cancellation.
- 4. Anyone who has a body temperature exceeding 37.5 degree Celsius or has any Covid-19 symptoms or is tested positive for Covid-19 during the Race Period shall NOT be allowed to participate in KLBR.
- 5. In addition to the above, anyone who has been in close contact with a Covid-19 positive person less than 14 days prior to the Race Period shall also not be allowed to participate in KLBR.

C. Race Format

- 1. Each team member is required to run a minimum distance of 3km anywhere outdoor in their safe place. KLBAR does not condone any form of cheating and any form of cheating will result in immediate disqualification of the team from the race.
- 2. The 'Elapsed Time' (NOT the 'Moving Time') of all 3 runners in a team will be used to determine winners.
- 3. No substitutions are allowed before or on race day without prior written consent from KLBAR.
- 4. There shall be NO running on treadmill. Any use of equipment such as roller blades, e-scooters, bicycles, motorcycles, and any form of vehicle, machinery, equipment whether powered by electronic means or otherwise and whether in part or in whole are STRICTLY PROHIBITED.
- 5. The distance shown on STRAVA app will be taken into consideration regardless of any other variation of distance shown on the participants' other wearable or applications.

D. Race Requirements

- 1. A Participant must be 18 years and above on the race day to participate in the KLBR.
- 2. Participants must be physically fit and in good health to complete the race distance.
- 3. Participants are responsible for their own personal health insurance and well-being.
- 4. KLBAR assumes no responsibility for any injury or damage that occurs from training, during or as a result of the KLBR. Participants are encouraged to consult with their medical practitioner prior to the KLBR.
- 5. The KLBR is opened to all members of the Malaysian Bar, pupils in chambers, and anyone who holds a LL.B Degree subject to Rule (6) and Rule (7) below
- 6. Each team must consist of three (3) members with a minimum of one (1) male runner and one (1) female runner.
- 7. Each team must consist of at least two (2) existing practising lawyers practising in Malaysia and/or pupils reading in chambers in Malaysia with the option of having one (1) member who holds a LL.B Degree.
- 8. KLBC reserves all rights to reject and/or cancel any registration of any team which fails to fulfill the Race Requirements stated herein.

E. Submission of results

- 1. Go to website vr.checkpointspot.asia and click the event thumbnail.
- 2. Key-in your Order ID and/or IC Number. Kindly fill in all the information needed.
- 3. Each team must submit and upload all three (3) runners' result by syncing their STRAVA records onto Checkpoint Spot or upload screenshots of their STRAVA app

to Checkpoint Spot showing (a) name of team member (b) date and time (c) distance (d) elapsed time and (e) elevation gain.

4. Results will be displayed at leader board after verification.

F. <u>Cancellation and Disqualification</u>

- 1. After registration and payment of registration fees, there will be no fee refund for a Participant who does not eventually take part in the KLBR, for any reason whatsoever.
- 2. Participants are not allowed to transfer his or her race entry to another party after his or her registration is confirmed.
- Any Participant who commences its run before the commencement of the Race Period
 of the race OR runs after the Race Period OR does not fully complete the distance of
 3km will be disqualified.
- 4. A team whose team member who does not run within the specified date and time will be disqualified.
- 5. Results as determined by the KLBAR shall be FINAL and no appeal will be allowed. No dispute will be entertained.
- 6. KLBAR reserves all rights to disqualify any team whose member/members are found to be cheating, refusing to adhere to the R & Rs and/or in any way behaving in a manner which KLBAR in its absolute discretion finds to be offensive or inappropriate.

G. Runners' entitlement

- 1. All three (3) team members in a team who successfully complete the race (3 x 3 km) within the specified date and time will be awarded with a Finisher Medal and an Event Tee Shirt each within 21 working days after the Results' Submission Cut-off Time.
- 2. Each team's Finisher Medals and Event Tee Shirts are to be delivered to the Captain with the following applicable delivery fees (to be borne by participants). No requests thereafter will be entertained. Individual dispatches will NOT be entertained.



The Fastest Male Runner and the Fastest Female Runner will have their names engraved on the Challenge Trophy.

H4. Delivery

All prizes will be delivered to the Team Captain who will be responsible to distribute it accordingly.

I. Results
