



# Special COVID19 Protocols

## RULES & REGULATIONS

### 24. Special Rules and Regulations on Covid 19 protocols.

- (i) The participant shall declare during registration, their Status of Vaccination
- (ii) To register there is a requirement for at least 2 doses of vaccination or whichever is the current requirement by the Ministry of Health\*
- (iii) Should this declaration be false and untrue and should any transmission case of Covid 19 be identified from the event, the Organiser reserves a right to take legal charges or seek legal rights that may arise from this false declaration.
- (iv) There will be a separate document for Covid 19 SOP Compliance known as the Code of Conduct which will apply to all of the participants and everyone that is in the venue and involved in the event. All participants are deemed to have consented and agreed on the terms and conditions therein. Please download them from our website or emails.
- (v) Should the Participants fail to observe and comply with the terms and conditions therein, thus caused or procuring to cause the risk of transmission whether to be higher or directly caused or procuring to cause the Covid 19 cluster or transmission from the event, the Organiser reserves the right to claim compensation from the Participant who failed to observe the SOP for Covid19 Compliance. The compensation shall not be limited to the losses or damages from the penalties imposed by the Government but to other reasonable losses suffered from crisis management and public relations management to other necessary steps to be taken in the aftermath of the Covid 19 transmission from the event
- (vi) We advise the participants to read the Code of Conduct which will be part of the registration documents and can be downloaded from the website.
- (vii) These strict Covid 19 protocols are vital to ensuring a safe and healthy environment for all other participants of the event and the Participants must comply with the terms and conditions.
- (viii) There may be Covid -19 insurance medical policy offered by various insurers under our Event partners We advise you to insure against these policies. We maybe procuring such policies but only for our crew and staff.
- (ix) The Participants are advised that the Event will implement and mobilize an Alternate Event Methodology should the situation for the Covid 19 transmission becomes a higher risk.
- (x) The Alternate Event A will be the hybrid version that consists of small numbers of physical runners for each category to which the total numbers will depend on further instruction by the relevant Ministry. These will be the Elite runners or athletes who are vying for competition prizes.
- (xi) The other registered participants will be automatically converted to virtual participants and the entitlement items can be collected at a given place post-event to be made known.
- (xii) If No Physical presence nor any form of mass gathering can take place as a result of a directive from the Government or the relevant Ministries and authorities, all participants will be converted to Virtual running and all the participants will receive an automatic 40% discount from the registration fee for the MWM2023.
- (xiii) The Participants is also advised that during registration of the Event, there is a requirement to sign consent and agreement to the Rules and Regulations of the Event which now includes the Covid-19 SOP Compliance terms and conditions. Therefore all registered participants are deemed to agree
- (xiv) Those who have yet to receive full vaccination status, you may declare fitness upon a PCR test before event d.
